BOOK VALUE PER SHARE AS OF MARCH 31, 2017**

OLD GREENWICH, CONNECTICUT, APRIL 7, 2017—Ellington Financial LLC (NYSE: EFC) ("Ellington Financial" or the "Company") today announced that its estimated book value per common share as of March 31, 2017 was \$19.75, or \$19.46 on a diluted basis. Estimated book value per share on a diluted basis takes into account securities convertible into the Company's common shares. These estimates are subject to change upon completion of the Company's month-end valuation procedures relating to its investment positions, and any such change could be material.
