

Income Tax Treatment of 2023 Distributions on Series C Preferred Stock of Arlington Asset Investment Corp.

8.250% Series C Fixed-to-Floating Rate Cumulative Redeemable Preferred Stock

During 2023, Arlington Asset Investment Corp.¹ (“AAIC”) was deemed to have paid total distributions of \$1.546875 per share on its Series C preferred stock. The Federal income tax classification of the distributions deemed paid in 2023, as they are expected to be reported on Form 1099-DIV, is set forth in the following table:
